The use of ICT (Information and Communication Technology) including the internet, email, learning platforms and devices are an integral element of learning in our schools. To make this as successful and as beneficial as possible for all learners, we expect all pupils to act safely and responsibly when using technology both within and outside of the school environment. This is particularly relevant when using social network sites.

The Federation of St. Cuthbert's and St. Sebastian's are members of National Online Safety, who equip school staff, parents and children with the knowledge they need to understand online dangers and how best to react should an incident arise.

The following ICT & Internet Acceptable Use policies for both parents / carers and pupils are intended to help share the importance that the federation places on keeping children safe with particular regard to online safety. Reading and signing the School Acceptable Use Policy helps us to maintain responsible use of the internet and school equipment whilst safeguarding the pupils in school.
